1. Configuration and rejection of Cookies

FIRST-PARTY COOKIES: Those created or managed by CaixaBank S.A. The website www.caixabank.it uses first-party persistent *cookies* for the following purposes:

Technical Cookies: Cookies that allow users to browse in a website, platform or application and use the different options or services existing in these to, for example, control data traffic and communication, identify the session, access restricted access sections and use security elements during browsing.

Analysis Cookies: Used to monitor and analyse the behaviour of web users, to create browser profiles in order to make improvements to the range of products and/or services available, according to usage data analysis.

THIRD-PARTY COOKIES: Those administered by third party companies that provide technical, analysis or customisation services to CaixaBank S.A.

The list below shows third parties that can configure and access the *cookies* belonging to a user's device (with the required information and consent) and the purposes for which the stored information is used:

2. How to disable or delete *cookies*

Most web browsers allow users to manage their *cookie* preferences at any time. Users can set their browser to reject or delete specific *cookies* according to their preferences. *Cookies* can be configured on a web browser as follows:

Users may withdraw their consent to the use of *cookies* on their browser using the above.

Users should be aware that certain features of the content of the www.caixabank.it website are only available if they allow *cookies* to be installed on the web browser. If they decide not to accept or to block specific *cookies* (according to their purpose), this may partly or fully affect the normal functioning of the website and block access to some services thereof.

3. Information on data processing.

3.1. Data controller

3.4. Profiling

3.5. Data recipients

3.6. File retention period

Data obtained through the use of cookies accepted by the user will be stored for a period of 12 months.

3.7. Transfers to third-party countries

At CaixaBank, we process your data within the European Economic Area and, in general, we hire service providers that are also located within the European Economic Area or in countries that have been declared to have an adequate level of protection.

If we need to use service providers that perform processing outside of the European Economic Area or in countries that have not been declared to have an adequate level of protection, we would ensure to guarantee the security and legitimacy of the processing of your data.

For this, we demand suitable guarantees from those service providers in accordance with that established in the General Data Protection Regulation so as to ensure they have, for example, implemented binding corporate standards that guarantee the data protection in a manner similar to that which is established by European standards, or that they subscribed to the standard clauses applicable within the European Union.
